

TERMS AND CONDITIONS FOR UNITED ASIA FINANCE LIMITED'S NEWLYWEDS LOAN OFFER

- 1. The Newlyweds Loan Offer by United Asia Finance Limited ("the Company") includes a 0% interest personal instalment loan ("0% Interest Offer") or a HK\$500 HKTVmall electronic gift coupon ("e-Coupon Offer"). The promotion period commences on 19 August 2019 and expires on 18 November 2019, both dates inclusive (the "Promotion Period").
- 2. This offer is applicable to newlyweds ("Eligible Newlyweds") or engaged couples ("Eligible Engaged Couples") within the Promotion Period .
- 3. Eligible Newlyweds refer to couples whose marriage contract date was within 1 year from the date of application. Eligible Engaged Couples refer to couples whose marriage contract date will be conducted within the following 3 months.
